## Instruction on the closing of the Academic Year 2019/2020 at FAMU

Dear students,

Considering the non-standard course of the summer semester of the running academic year, we are sending you instructions that should help you complete your studies successfully this year. Therefore, please pay due attention to the information provided below.

The first part of the instructions relates to the disrupted time of study and the implications for the students. The second part contains specific information on several measures that should make completing your studies easier this year.

## 1) Period of disrupted study (PDS)

#### What does this mean?

The period of studies **from 1 March to 31 August 2020** was statutorily designated as PDS. This period of time is not included in:

- The duration of studies relevant for determining the charge for prolonged studies (the period before the charges will be assessed is prolonged by six months)
- Maximum duration of studies for completing study obligations (the maximum duration of studies is extended by six months; the maximum period of studies at FAMU is six years for bachelor's programmes and four years for master's programmes).

## What does that mean?

- The charges will not be assessed in July
- It will be possible to take **extraordinary state final examination (SZZ)** at the end of the winter semester of the 2020/2021 academic yeare
- Consider PDS prior to filing applications for the interruption of studies or for an individual curriculum (distribution) it is possible that the applications will not be required due to PDS
- If a student's studies are interrupted in PDS, this period is not included in the total duration of the interruption if the Department of Student Affairs applies for this.

### 2) Conclusion of the 2019/2020 academic year at FAMU

- Modules not completed can be replaced by **extraordinary modules**; they are planned for July (they will be announced in the week beginning with 20 June, <u>see here</u>); a selection of some is as follows:

- 300MMP / Extraordinary contribution / detailed specification in KOS
- 300MVKHD / Selected chapters from game design / 15 July / full time / a series of lectures
- 300MPPS / Prague Pride Stream / July / hands-on exercise
  - REGISTRATION DEADLINE IS 3 DAYS PRIOR TO THE DATE OF THE MODULE!
- We are offering two extraordinary modules in cooperation with the AMU Sports, Rehabilitation and Movement Centre (CPPSR AMU):
  - 2 July / TAI-CHI / 10 am 1 pm / Michael Kňažko / Stromovka / 703TAI
  - 14 July / Beach volleyball / 3 4:30 pm / Simona Fiřtová / Žluté lázně / 703VOL
- **Submission of theses on extraordinary deadlines:** 21 days prior to the state final examination date (diploma theses); 14 days prior to the state final examination date (bachelor theses)

## The closest important dates for the students of bachelor's and master's programmes:

- 31 July / End of the regular examination period for the summer semester of 2019/20
- 1 September / Submission of work required for the admission procedure for the master's studies 2020/21
- 11 September / Deadline of registration of attestations for the summer semester in KOS
- 25 September / Registration in the 1<sup>st</sup> year of the master's programme for the academic year 2020/21
- 30 September / Deadline for finishing the shooting of summer semester exercises at FAMU Studio
- 2 October / Additional date for the registration in the 1<sup>st</sup> year of master's programmes 2020/21
- 31 October / Settlement and completion of production of the exercises presented during the clausura or state final examination
